

# SAY NO TO GREYCOATS.....!!!

WHILE North Londoners have been using guerilla tactics of all sorts to rid themselves of one Air Marshal (Inspector at the Archway Road Inquiry), in Waterloo another Air Marshal has been presiding over long-drawn-out trench warfare in the Coin Street Road Closure Inquiry.

It's something of a mystery where they get these people from. Someone up there seems to think that people who were only fit to be Air Marshals are qulified to make decisions about OUR future. This one. after listening to four weeks of detailed arguments, seems no brighter than when the Inquiry opened on February 7 Whether this is because his ears are closed or because there's nothing between them, it's hard to tell.

The Inquiry looks set to end on March 15th. It's purpose is to decide whether the office developers, Greycoats, should be allowed to close Upper Ground and other roads in order to build their office development.

The Inspector started off by refusing demands for an adjournment of the Inquiry; and has since shown that he sees local residents and other objectors as second-class parties to the Inquiry. So have Greycoats, one of whose lawyers called a session of the Inquiry at which local residents were giving evidence

a 'Mickey Mouse show'.
Despite this, there has
been a tremendous response
from residents and workers
in the area. Some 60 individuals and organisations have
given evidence about how the
proposed road closures and
the office development would
affect Waterloo and North
Southwark.

One frustrating feature is that it has never been clear whether the whole Inquiry was not a waste of time: Greycoats may not be able to build their scheme anyway - either because they can't get the land they need from the GLC or because they can't find anyone to put up the money to build useless office blocks.

The Inquiry, from the local point of view, has meant a lot of work to ensure that they don't get their road closures - and so drive a final nail into the coffin of their scheme.

April 14th is the deadline: by then, Greycoats either can or cannot fulfil their side of the agreement with the GLC. If they can, it will allow them to buy the Coin Street sites; if they cannot, their scheme is truly dead.

And a great victory will have been won for local residents. So watch out for more news next month!

### TMUCH NEEDED **IMPROVEMENTS**

Shoppers in Tower Bridge Road may have noticed that work has started on paving over part of Bermondsey Street. The idea is to make the area safer for pedestrians. and generally more pleasant to shop in.

The rest of the £130,000 scheme includes a new bus shelter further down Tower Bridge Road, improvements to the "Trocette" site open space, and a wider traffic island at the corner of Grange Road.


The improvements are being carried out by Southwark Council. Last summer they held two consultation meetings where local people were able to give their views on what needed doing.

Some of the suggestions put forward have now been taken up.

However the scheme has caused some concern to market stallholders in Tower Bridge Road, who fear that the repaying work will affect their trade, especially as it coincides with an increase in stall charges.

Southwark Council is to be asked to postpone the increase for Tower Bridge Road stallholders, until the improvements are completed.

In the long term, though, the stallholders along with the rest of the local community, should benefit from the more pleasant shopping environment which will be created.

#### **EMERGENCY CAMPAIN**

Health Cuts - Protest Campaign Launched.

"No cuts in the health service' was the clear message from a protest meeting on Thursday (16th February) held to launch a campaign against spending cuts in the West Lambeth Health District.

Health workers and local people heard from Opposition Health spokesman Frank Dobson and local M.P.Stuart Holland how Government cuts in the N.H.S. were putting lives at risk. West Lambeth District Health Authority (DHA) member Cllr. Steve Bubb explained how this was affecting local services. "Over £2 million is coming off this years budget." he said, "which will mean over 100 jobs being lost and a drastic reduction in the standards of patient care".

Last Monday (13th Feb) the DNA decided, by 7 votes to 6 to

make compulsory redundancies so as to stay inside the Government cash limits. As the DHA Chairman was forced to admit, "no one can pretend that this will not affect patient care."

Now the West Lambeth Health Emergency Campaign plans to work to get that decision reversed. A petition was launched and a series of lobbies, meetings and other protests are planned over the next few months.

The Health Emergency Campaign expressed particular concern over the secretive nature of the DHA. At the DHA meeting on Monday the Chairman first ruled out of order a resolution to hear a delegation from the health workers union, COSHE, and then tried to have the discussion on next years budget taken in private session; Councillor Bubb was threatened with removal from the Authority for reporting back to Lambeth Council on the proposals for cuts.

'The Health Service must be accountable to the community." Campaign convenor Greg Tucker told the meeting. "We cannot let small groups behind closed doors take decisions which will put lives at risk. We must inform and arouse the people of Lambeth. We deserve a decent health service - we will defend our N.H.S."

### WHO ARE THEY ....?

A new campaign, called Southwark Against Government Attacks on Local Democracy (SAGA) has been set up to campaign in Southwark against four government Bills. These are:

- 1. The Rates Bill, to "rate-cap" local councils, in other words set their rate for them.
- . The Public Transport in London Bill; to take London Transport away from the GLC's control, and sell off the profitable parts.
- 3. The "Paving" Bill, to abolish next year's GLC elections.
- 4. The Streamlining the Cities Bill, to abolish the GLC altogether.

SAGA includes trades unionists, pensioners, tenants' associations, and anybody else who wants to fight these Bills. Our aim is to bring together all those who will suffer from the government's attempts to control local councils and force them to make cuts in jobs, public services, and grants to community groups.

On 23rd March we are holding a "Funeral for Local Democracy, Jobs and Services". A minibus will carry a "coffin" symbolising the death of local democracy around the borough. People will come out from workplaces, schools, shops and housing estates to lay "wreaths" on the coffin as it passes. When we reach County Hall at the end of the day the wreaths will be presented to Southwark's MPs as a protest at the Government's plans.

This month I shall focus on "George and Margaret's Garden Stall" in the Lower Marsh Market in Waterloo. In 5 years of careful buying from their stall, which is at the Westminster Bridge end of the market, I haven't suffered a single failure (where the blame lay with them!)

George and Margaret are a husband and wife team who run their stall Monday to Friday with the help of Julie and other assistants. They have their own nursery and raise as many of their own plants as possible. George has been working a stall for nearly 30 years, Margaret has been on their garden stall for the last 7 years in Waterloo. With that sort of knowledge and experience they are always happy to offer friendly advice or information to local people new to gardening. They always have a very wide range of plants and are always ready to look for or order any plant that you require which is not in their stock.


At the moment they have a wide range of indoor and outdoor plants, bulbs, perennials, biennials, shrubs, trees, herbs and onion/shallot sets. Most are very reasonably priced between 50p and £1. 

BUTLERS WHARF - THE LDDC THE SERVANT OF THE RICH.

An application has been submitted by Conran Roche to the London Dockland Development Corporation, to redevelop Butlers Wharf, Shad Thames. He wants to provide a mix of uses including luxury housing, boutiques and

There are 9,000 unemployed in North Southwark, the majority of whom need industrial employment. This scheme will do nothing for the unemployed of Bermondsev. What it will do is take away our last remaining site of any significant size that should continue in indust fial use.

Luxury flats are to be provided at a cost of £250,000. But the 2,000 families on the waiting list desperately need a council house.

Lil Patrick chair of Tooley Street Tenants Association commented "We are going to love this when our places are falling about our ears." What about the shops? "You can just imagine all our OAPs going down to those boutiques, wine bars and squash courts.

Butlers Wharf itself is an area of warehousing Some are still in use providing employment for 100 people, and the occupying firms wish to emain. With investment, the buildings could be modernised in a way that would preserve exist ing firms and provide premises for new start un

firms and local based initiatives. This is what the local community want and need; this is what the 9,000 unemployed want: this is what Southwark council have identified the site for. following full public consultation, in the North Southwark Plan.

If the L.D.D.C. grant permission, as they did for offices and luxury housing on Hay's Wharf and the Anchor Brewery sites, they will once again have shown a complete and utter contempt they have for th views and needs of the local community and for the policies of the democratically elected local council.

Plans to build a speculative office scheme on land at the rear of Beckett House in Lambet Palace Road were decisively reflected at a recent planning inquiry. The site was zoned for light industrial use in the Waterloo District Plan and the developers wished to overturn this planned use. It soon became clear that they had no particular tenants for the development and merely wished to indulge in the well known game of property speculation. Thankfully the combination of the Association of Waterloo Groups, Lambeth and G.L.C. mounted a successful campaign to stop this. The message should at last be getting through in the world of property finance across the way in the city : Waterloo means business - Speculators keep out

#### AN OPEN LETTER TO SIMON HUGHES.

#### DEAR SIMON HUGHES.

#### HOUSING BENEFIT CUTS -- NO REAL CHANGE.

The changes in the housing benefit cuts proposed by the Government are mean and dishonest. The cuts have not been reduced, they have simply been redistributed. There is no change but a cosmetic one. The Government is not giving the money back, but changing the way that it takes money from people.

#### POOREST PEOPLE STILL AFFECTED

Mr Norman Fowler has stated that the aim of the changes is to help people on the lowest incomes. But even pensioners and families on supplementary benefit, the poorest people in Britain, will still be affected by the cuts.

### CUTS DELAYED, NOT STOPPED.

Some of the worst aspects of the cuts are now to be put off until November 1984. It will be six months longer before they are implemented, but the cuts will still be made. Local councils have told the Government that they cannot possibly put the changes into force by April anyway. To cap it all, this delay will be paid for by depriving people of the promised increase in the children's needs allowance. The Government is saving its face at the expense of poor families with children.

#### CITIES ATTACKED AGAIN.

In November the Government wants to change the High Rent Scheme so that far fewer councils can operate it. Southwark would certainly lose its High Rent Scheme if the new proposals came into force, and thousands of Bermondsey tenants would lose money. This cut mainly affects poor people living in cities like London. The Government has made cuts on city dwellers again and again. This aspect of the cuts is particularly unfair.

### POVERTY TRAP FOR LOW EARNERS

The cuts make the poverty trap for families with low earnings even worse. On 12 February the Sunday Times quoted a figure of half a million families losing 70p in the f of every £1 they earn, under the new cuts. The richest businessman in Britain loses only 60p in the £. The Government is once again taking from the poor to give to the rich.

### DIFFERENT RULES FOR RICH & POOR.

The same amount of money as is being 'saved' by the housing benefit cuts could be saved by some very small changes in the help given to owner occupiers with mortgages. If the Government restricted mortgage interest to the standard rate of taxation (standard rate tax is paid by people earning up to about £17000 per year), and reduced the ceiling on mortgages eligible for relief from £30000 to £25000, the saving would be exactly the same. Such cuts would affect only richer owner occupiers, but the Government prefers to make cuts that affect the poorest people

#### REVIEW

The Government has at last agreed to review the whole Housing Benefit Scheme! But it is making sure that it gets the answers it wants to hear. The Social Security Advisory Committee (SSAC) is the Government's expert watchdog body. But the SSAC criticised the housing benefit cuts, so they are not being given the job of reviewing housing benefit. Instead Mr Norman Fowler will appoint for himself "a small review team". This is yet another shameful abuse.

We therefore unite in asking you to fight these cuts and to fight for a fair review of the whole Housing Benefits Scheme.

# CO-OP SKILLS EXCHANGE....?

Most of the co-ops in Lambeth are small. They don't often have vacant jobs so people who want to work in a co-op generally have to set up new ones themselves.

Lambeth Co-operative Development Agency has set up a Skills Exchange to help people who want to set up co-ops get in touch with others with compatable skills.

The Skills Exchange is essentially a list of names and addresses, skills and experience, as well as ideas for setting up co-ops. With this list, the CDA can put suitable people in contact with each other.

Remember, this is not an employment exchange - to set up a co-op requires a great deal of work and commitment before there are any jobs to show for it. The attitudes of the group of people from whom the co-op will grow are just as important to its success as the skills and finance invested.

If you want to set up a co-op, if you have a particular skill or just a good idea for a co-op, write to us giving details, and we'll put you on the Skills Exchange.
On the Skills Exchange at present we have the following potential co-ops and people looking for other co-operators:

1. Asian Restaurant - looking for somebody with sales experience - not necessarily in catering, and not necessarily with experience in Asian cooking.
